**SCHEDULE**

Schedule "A" - Pound Fees

The Municipal Council of the Corporation of the City of London enacts as follows:

**SHORT TITLE  
PUBLIC POUND BY-LAW**

**Part 1  
POUNDKEEPER - APPOINTMENT - DUTY**

**1.1 Animal Care and Control Centre (London) - appointed**

The Council re-affirms, and appoints Urban Animal Management Inc. carrying on business as Animal Care and Control Centre (London) to serve in the office of Poundkeeper, during the pleasure of the Council and to carry out the provisions of the Pounds Act.

**1.2 Animals - fowl - running at large - impounded**

It shall be the duty of the Poundkeeper of the City of London to impound any animal or fowl running at large or trespassing on any property contrary to the provisions of the Dog Licensing and Control By-law, and the Animal Control By-law.

**Part 2  
PUBLIC POUND - LOCATION**

**2.1 Pine Valley Boulevard**

The public pound shall be from time to time the premises of Urban Animal Management Inc. carrying on business as Animal Care and Control Centre (London) located at 121 Pine Valley Boulevard, in the City of London.

**Part 3  
POUNDKEEPER'S RECORD**

**3.1 Book - furnished - by Treasurer - contents**

The City Treasurer shall furnish the Poundkeeper with a book in which the Poundkeeper shall enter the following:

- (a) description of every animal impounded;
- (b) name of person presenting or sending animal for impoundment;
- (c) year, month, day and hour animal received;
- (d) year, month, day and hour if animal redeemed;
- (e) amount of damages or penalty;
- (f) fees paid by party redeeming;
- (g) proceeds of sale if any.

**3.2 Book - produced - for inspection - at all times**

The Poundkeeper shall at all times produce the record book for inspection when required to do so by the Mayor, City Engineer, Councillors of the City or such person as may be designated by them.

**Part 4  
COMPENSATION**

**4.1 Services - compensation for - set out - Schedule `A'**

The compensation to be allowed the Poundkeeper for services rendered by him in carrying out the provisions of this by-law shall be set by Council from time to time and is more particularly set out in Schedule "A" of this by-law.

**Part 5**  
**REPEAL - ENACTMENT**

**5.1 By-law - previous**

By-law P.H. 66-125 is hereby repealed.

**5.2 Effective date**

This by-law comes into force on November 15, 1993.

\* actual costs will be passed to the owner of the animal or animals that are impounded. For example, the rental cost of a portable stall, trailer or space and supply of straw bedding as appropriate for housing species.

**NOTE:**

1. The fees and charges imposed by this by-law are due and payable:
  - (a) at the time of the transaction for which the fee or charge is imposed; or
  - (b) if subsection 1(a) is not applicable, upon the due date specified in any invoice issued by The Corporation of the City of London or its contractor to any person or party in connection with a fee or charge imposed by this by-law.
2. The fees, charges and penalties imposed by this by-law can be paid at the Licence Agent by cash, cheque, debit, or credit card.
