What is Proposed?

Zoning and Official Plan amendment to allow:

- A vertical expansion to the W12A operations area and the existing material drop off area.
- A portion of the subject property is to be zoned to the Waste & Resource Management (WRM1) zone as well as an Open Space (OS5) zone to identify and protect ecological features.

Requested Zoning By-law Amendment

Possible change to Zoning By-law Z.-1 FROM an Agricultural (AG2) & Waste Resource Management (WRM1) Zone TO an Open Space (OS5) & Waste Resource Management (WRM1) Zone. Changes to the currently permitted land uses and development regulations are summarized below.

Current Zoning

Zone: Agricultural (AG2) & Waste Resource Management (WRM1) Zone **Permitted Uses:** Agricultural uses; Livestock facilities provided that such facilities are located at least 300 metres from the City's Urban Growth boundary; or in accordance with the MDS regulations, whichever is greater; farm dwelling; forestry uses; kennels; conservation lands; wayside pits; nursery; passive recreation use; farm market; small wind energy conversion system; greenhouse farm; compost facilities; aquaculture; agricultural research station; manure storage facility; mushroom farm; municipal waste disposal facility; leachate pre-treatment/hauled liquid waste facility; public drop-off for municipal hazardous and special waste; community recycling and drop-off depot; yard waste composting facility; material recovery facility.

Requested Zoning

Zone: Open Space (OS5) & Waste Resource Management (WRM1) Zone **Permitted Uses:** Conservation lands; conservation works; passive recreation uses which include hiking trails and multi-use pathways; managed woodlots; municipal waste disposal facility; leachate pre-treatment/hauled liquid waste facility; public drop-off for municipal hazardous and special waste; community recycling and drop-off depot; yard waste composting facility; material recovery facility.

The City may also consider the use of holding provisions, and additional special provisions to facilitate the proposed development.

Planning Policies

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. These lands are currently designated as Waste Management Resource Recovery Area in The London Plan.

The subject lands are in the Waste Resource Recovery Area in The London Plan. Uses permitted include landfills and related uses necessary to the function, operation and education of all aspects of waste reduction, re-use, recycling, management, resource recovery, treatment and waste disposal.

How Can You Participate in the Planning Process?

You have received this Notice because someone has applied to change the Official Plan designation and the zoning of land located within 120 metres of a property you own, or your landlord has posted the notice of application in your building. The City reviews and makes decisions on such planning applications in accordance with the requirements of the Planning

Act. The ways you can participate in the City's planning review and decision-making process are summarized below.

Attend This Public Participation Meeting

The Planning and Environment Committee will consider the requested Official Plan and zoning changes at this meeting, which is required by the Planning Act. You will be invited to provide your comments at this public participation meeting. A neighbourhood or community association may exist in your area. If it reflects your views on this application, you may wish to select a representative of the association to speak on your behalf at the public participation meeting. Neighbourhood Associations are listed on the <u>Neighbourgood</u> website. The Planning and Environment Committee will make a recommendation to Council, which will make its decision at a future Council meeting.

What Are Your Legal Rights?

Notification of Council Decision

If you wish to be notified of the decision of the City of London on the proposed official plan amendment and/or zoning by-law amendment, you must make a written request to the City Clerk, 300 Dufferin Ave., P.O. Box 5035, London, ON, N6A 4L9, or at <u>docservices@london.ca</u>. You will also be notified if you speak to the Planning and Environment Committee at the public meeting about this application and leave your name and address with the Clerk of the Committee.

Right to Appeal to the Ontario Land Tribunal

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the proposed official plan amendment is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the proposed official plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.




Figure 1: Concept Plan depicting the re-zoning of the lands.
