

Application Details

Requested Zoning By-law Amendment

Possible change to Zoning By-law Z.-1 FROM an Environmental Review (ER) TO a holding Associated Shopping Area Commercial (h-17*ASA1/ASA2/ASA6) Zone and holding Light Industrial (h-17*LI6) Zone. Changes to the currently permitted land uses and development regulations are summarized below.

The Zoning By-law is available at london.ca.

Current Zoning

Zone: Environmental Review (ER)

Permitted Uses: Conservation lands; Conservation works; Passive recreational uses;

Managed woodlot; Agricultural uses.

Requested Zoning

Zone: Associated Shopping Area Commercial (ASA1/ASA2/ASA6) & Light Industrial (LI6) **Permitted Uses:** ASA: Animal hospital; Convenience service establishments; Convenience stores; Dry cleaning and laundry plants; Duplicating shops, Financial institutions; Grocery stores; Restaurants; Retail Stores; Personal service establishments; Pharmacies; Printing establishments; Video rental establishments; Brewing on premises establishment; Repair and rental establishments; Service and repair establishments; Studios; Supermarkets; Commercial recreation establishments; Taverns. LI: Any use permitted in the LI1 & LI2 Zone variation; building or contracting establishments; Storage depots; Terminal centres; Transport terminals. **Height:** <12 metres

The City may also consider the use of holding provisions, or additional special provisions.

An Environmental Impact Study has been prepared to assist in the evaluation of this application.

Planning Policies

- Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. The subject lands are in the Shopping Area Place Type in The London Plan, permitting retail, service, business, recreational, social, educational and government uses. The subject lands are also in the Light Industrial Place Type in The London Plan, permitting a broad range of light industrial uses.
- The subject lands are within the Wellington Road/Highway 401 Area of the Southwest Area Secondary Plan (SWAP), designated Commercial and Industrial pursuant Schedule 17 of SWAP.

How Can You Participate in the Planning Process?

You have received this Notice because someone has applied to change the zoning of land located within 120 metres of a property you own, or your landlord has posted the notice of application in your building. The City reviews and makes decisions on such planning applications in accordance with the requirements of the Planning Act. The ways you can participate in the City's planning review and decision making process are summarized below.

Reply to this Notice of Application

We are inviting your comments on the requested changes at this time so that we can consider them as we review the application and prepare a report that will include Planning & Development staff's recommendation to the City's Planning and Environment Committee. Planning considerations usually include such matters as land use, development intensity, and form of development.

This request represents residential intensification as defined in the policies of the Official Plan. Under these policies, Planning & Development staff and the Planning and Environment Committee will also consider detailed site plan matters such as fencing, landscaping, lighting, driveway locations, building scale and design, and the location of the proposed building on the site. We would like to hear your comments on these matters.

Attend This Public Participation Meeting

The Planning and Environment Committee will consider the requested Official Plan and zoning changes at this meeting, which is required by the Planning Act. You will be invited to provide your comments at this public participation meeting. A neighbourhood or community association may exist in your area. If it reflects your views on this application, you may wish to select a representative of the association to speak on your behalf at the public participation meeting. Neighbourhood Associations are listed on the Neighbourgood website. The Planning and Environment Committee will make a recommendation to Council, which will make its decision at a future Council meeting.

What Are Your Legal Rights?

Notification of Council Decision

If you wish to be notified of the decision of the City of London on the proposed zoning by-law amendment, you must make a written request to the City Clerk, 300 Dufferin Ave., P.O. Box 5035, London, ON, N6A 4L9, or at docservices@london.ca. You will also be notified if you speak to the Planning and Environment Committee at the public meeting about this application and leave your name and address with the Clerk of the Committee.

Right to Appeal to the Ontario Land Tribunal

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.


Notice of Collection of Personal Information
